## V. Unfinished Business

#### a. Sidewalks (TAP)

Jeff Nagoda, DelDOT Deputy Director of Planning, will be hosting a workshop Jan 18<sup>th</sup>. Jeff was briefed on the request submitted last meeting to widen driveway. Jeff stated when first drawings are proposed we will be able to modify. At that time it would not be a major change. The sidewalks will be completed in phases. The federal government is going to sponsor 80% of Phase I, which is a million dollar project. Jeff Nagoda also stated that the roadway will also be redone as it was previously funded and put on hold for sidewalk project.

## b. Delaware State Police/Speeding/Road Signage

Mark & Suzanne attended a meeting at Troop 3 and met with a Captain and Lieutenant. We are not like to lose any more than 65%. We have limited funds which require a limit of 12 hrs. a month. DSP requested that we be more specific on how much over speed limit the town was willing to allow. After a lengthy discussion, the Council agreed on the suggested speed to stop. Lawson & Spiegelman will be purchasing 3 speed signs at the cost of \$9582.00. These will be permanent signs placed near the school, on Rt. 44, & Rt. 11. They have been approved. These signs will also collect data and record in the cloud. This data will aid us in the scheduling of our DSP patrols.

Suzanne motioned, Rebekah seconded, that any motorist travelling at the speed of 30 mph and over within the town limits will be stopped by DSP. Motion carried:

## a. Comcast Franchise Agreement

Chris Comer, Local Director of Customer Affairs from Comcast presented a new 10 year franchise agreement. Comcast requires this to work with local government where we provide cable service. Federal law requires a contract to provide infrastructure for cable service. Our old agreement was signed and dated in May 1988. The franchise agreement is not non- exclusive of other parties. This agreement also provides free service to town sites. There is also the option of a franchise fee (up to 5%) that can be added to consumer's bills at the town's discretion. It would earn the town about \$700 a year.
