a. Treasury (Suzanne Reported)

i. Citizens Bank Account

a. Sidewalks (TAP)

Ray reported that the State had put out the Request for Bid that had close date of October 16. Work to begin in February 2019 or later.

b. Delaware State Police/Speeding/Road Signage

Citations written vary from 2 to 11 on a single shift. One DSP shift generated no citations and Mark addressed that particular shift with DSP. The Speed Sign on Main

street is intermitted with the signal to due tree shading it. Signs seem to be slowing drivers down. Data indicates that speed has decreased but there are still the one-off's that come through town in early AM hours traveling at excessive speed. It is difficult to schedule DSP to attempt to get citations for those incidents. Regarding the tree issue with the Main Street sign, we will need to get a new quote for trimming the tree. The State did trim the tree slightly but not enough to allow sunlight to get to it throughout the day

c. Fiscal 2019 Budget

Suzanne read the Proposed 2019 Budget for the 2nd official reading. Suzanne will have the 2019 Budget posted in the newspaper so that 2019 Budget can be passed in the December meeting.

d. Town Sign

\$1000 had previously been dedicated for beautification of the triangle property. The Electric post has been resurfaced but other improvements will be addressed at a later date.

e. Town Yard Sale

Town Yard Sale will be held on Saturday, September 8th. It rained on that date and only a few residents participated due to the weather. For future we will identify a "Rain-Date".

f. Hartly Holiday Event (December 8, 2018)
